## Council Connection

Recent Council actions from August 18 meeting:

- **Wireless Telecommunications**

**Facility Permit:** The Council approved two Wireless Telecommunications Facility Permits for AT&T which will allow the installation of antennas on two of the City's water towers and equipment shelters. Currently Sprint, T-Mobile and Verizon have facilities at the south water tower located at 745 County Road E, while Sprint, T-Mobile and Clearwire have facilities at the north water tower located at 5880 Lexington Avenue. The purpose of the two wireless sites is to fill gaps in coverage that currently exist. The agreement also includes a ground lease to allow for equipment shelters that will house electrical equipment and an emergency generator. This lease will generate roughly \$82,000 in annual revenue for the City.

- **City Withdraws from the Cable Commission:** The Council authorized the Mayor to send a letter to the North Suburban Cable Commission indicating Shoreview's intent to withdraw from the Commission effective December 31, 2014. This withdrawal will require the City to negotiate its own franchise renewal with Comcast.
